The, **Acharya Institute of Graduate Studies, No: 80-90, Soladevanahalli, Chikkabanavara post, Bengaluru-90**, affiliated to Dr.Man MohanSingh Bengaluru City University is hereby granted Extension of Permanent Affiliation under section (62)3, introduction of New courses under section 59(11), Closure of Courses under section 65(3) and Renewal and Continuation of Temporary Affiliation under section 59(17) of the Karnataka State Universities Act-2000 with effect from the Academic year 2025-26 as stated below:

Note: The report of the local inquiry committee for the year 2025-26 is enclosed. The affiliation has been renewed with for the approved student intake as fixed by the Syndicate. The college is directed to correct the deficiencies pointed out in the LIC Report, and submit a compliance report otherwise the Renewal of Affiliation Application for the year 2026-27 will not be accepted.

***A re-proposal has been sent to the government to revise the student quota for the Bachelor of Business Administration (G) course to 360-30=330, and action will be taken after receiving permission from the Government.**

Conditions:

1. The conditions mentioned in the local enquiry committee report must be fulfilled.
2. As indicated in the Government Order No: ED 29 UNE 2021 dated: 12-02-2021, college must take steps to fulfill all eight Defined Parameters within the next two years.
3. As directed by the Government, admissions to affiliated courses must be made compulsorily through the Government's UUCMS portal.
4. If the prescribed student admission exceeds the sanctioned intake, University will not approve the excess admissions.
5. Branches for any course/courses should not be increased without the prior permission of the University.
6. While admitting the students to the respective degree courses, the reservation orders issued by the Government from time to time must be strictly followed.

7. The rules/regulations and orders issued by the University from time to time regarding the college's students, teaching, and non-teaching staff must be followed. In accordance with the University's affiliation notification, student admissions to courses must be done without exceeding the student intake prescribed for the courses and without violating the eligibility rules prescribed by the University for the courses.
8. 50 percent of the prescribed student intake (50 percent) (100 percent for government colleges), must be admitted from the students sponsored by the University in respect of postgraduate degree courses, without exceeding the admission and other fees prescribed by the University from time to time.
9. In relation to the Vishaka v/s State of Rajasthan case, as per the Supreme Court judgment dated: 13-8-1997, any kind of harassment or sexual harassment of women/female students by any person (teaching/non-teaching/management) or student in the college, office, or workplace is a punishable offense. Any person/student involved in such activities may be dismissed from service/studentship. The college must establish a complaints committee as per the Supreme Court order to curb such offenses/activities.
10. The curriculum of the courses should be improved to the level of academically developing the students. The Principal/Management should treat students and in-service teachers with empathy.
11. The marks cards and other documents submitted by students for admission approval must be quickly distributed to the students after admission approval, and the University must be informed.
12. The college must issue marks cards, degree certificates, and other documents to students within a period of three months. ⁵¹A report must be submitted to the Registrar (Evaluation) regarding the marks cards and degree certificates remaining with them after the expiry of the period.
13. If students submit a request for the issuance of a transfer certificate, the transfer certificate must be issued to the students without causing any trouble. ⁵³In this regard, apart from the tuition fees for the uncompleted period of the year/semester, there is no permission as per the rules to collect any additional fees.
14. The college shall not collect any kind of capitation fee. 15. Kannada must be compulsorily used in administrative transactions.
15. The college management shall not unnecessarily withhold any student's marks card or other documents until the student's admission is approved by the University or beyond a period of 06 months, whichever is earlier.
16. If any student requests a transfer certificate by submitting an application, they should not be troubled when issuing it, and only the tuition fee for the remaining academic year/semester period shall be collected from them, and no other amount shall be collected.
17. The college must unfailingly submit an application for the renewal of affiliation of courses for the year 2026-27.
18. Colleges that have completed five years must immediately obtain NAAC accreditation.
The Principal must unfailingly submit the list of eligible teachers for evaluation work to the Chairpersons of the concerned Boards of Studies. Failure to do so will result in the cancellation of the college's affiliation.



As per the concurrence of Government of Karnataka vide letter under ref (1) above, Extension of Permanent Affiliation, Introduction of New Courses, Renewal of Temporary Affiliation has been issued vide notification in ref (2) above, in respect of Acharya Institute of Graduate Studies, No. 80-90, Soladevanahalli, Chikkabanavara post Bengaluru-90. Affiliated to Dr. ManMohansingh Bengaluru City University, In the said notification considering the approval of Government to the intake of students for BBA (G) course was mentioned as 300 instead of 330. In this regard a letter has been written to Government under reference (3) above seeking correction of intake. The Government permits letter under ref (4) has clarified that the student intake for BBA (G) course under Permanent Affiliation is 330. Accordingly the notification under ref (2) above is to be modified mentioning the student intake as 330. Accordingly the notification is corrected as follows:
