- The target groups observed in Vikasa, Sandeep Seva Nilaya, Parspara trust Nemmadi trust, Anugraha children's home, society of sister's redemption Jeevanalaya children's home, Manav special school and Rehabilitation center Nisarga grama are mainly associated with CHILDREN and WOMENS who are Abandoned, affected with Human trafficking, faced Domestic violence, Child Abuse
- The target group observed in Alur Grama panchayat, RUDSETI, Intell health, Gandharva ready-made garments factory, Nelamangala town police station are associated with GENERAL PUBLIC
- The target group observed in ondede are mainly the SEXUAL MINORITIES
- The target group observed in Durga India, Unath Bharath Abhiyan skill center, AWAKE organization are associated with WOMEN who are affected with domestic violence, Domestic Abuse, Dowry, Durga India also works for GENDER EQUALITY.
- The target group of Ashraya special school and Manav special school are CHILDREN who needs care with SPECIAL NEEDS

6. In what ways did orientation visits contribute to your professional growth and development?

As a social work trainee, the orientation visit has thought me various skills which I can implement in my professional life. As a social work trainee, I have gained numerous knowledge and functions of the organizations while I visited the organizations. The organization clearly gave me a picture of acquiring the specific knowledge or experience with which I can build my quality of standard in my professional life which includes responsibility transparency, loyalty, confidentiality that I, as a professional social work trainees would have while appearing with client.

7. Discuss the ways in which you tried to make use of supervisory guidance available at the Department

- During the field work, associate professor of the social work department accompanied the social workers trainees to the orientation visit, by the translation of language by the professor helped the social work trainees to grasp the methods and activities of the organization.
- While the social work trainees had doubts regarding the writing of report the professors of the department helped the trainees by clarifying the doubts

8. Discuss the major limitations faced during your Orientation Visits?

The major limitations faced during the time of orientation visit was:

- The social work trainees had only limited time to fully interact and connect with the community or organizations visited during the visit.
- Due to lack of limited time while visit the orientation visit the social work trainees could only know limited information about the visited organizations.

9. Major learnings of the Trainee

The major learnings of the social work trainees from the orientation visits are:

Serving, understanding and working for the community. the social work trainees have learnt the culture, values and background of the people of the community. One of the major learnings as a social work trainee are the challenges faced by the community and how they have come over those challenges the orientation visit have given the social work trainees impact knowledge and insights of dealing with the organizations

10. Major observations of the Trainee

The major observation which the social work trainees have observed during our visit was:

the organizations visited had various overcoming challenges, but the community was trying to deal with the challenges which was a great observation for the social work trainees as it was a inspiration for the trainees to get over their challenges.

wellbeing of the individuals and families were observed during the visits. The social work trainees also had an observation on organizational structure and other functions of the organization. By these observation the social work trainees can gather valuable information and insights of the organization.

11. SWOT Analysis

11.1 Strengths: The major strengths that contribute in the orientation visits are opportunity to build relationship with community members. This helps in establishing trust, a good rapport and a deeper understanding and knowledge of the needs and strengths of the communities or organizations. Also, as social work trainees we can gain insights into the organizations culture, policies and procedures. Through the observation and interaction with the community as a social work trainee we can have strengths to a professional social work for the community

11.2 Weakness: The weakness found during the orientation visit is that the social work trainees did not get enough time to interact to fully connect with the communities by which at times the social work trainees could not understand the challenges of that some orientation visit.

11.3 Opportunities: The opportunity which I found as a social work trainee was the opportunity to set up specific goals and priorities which can guide to develop the skills of the orientation, it can also help to provide information about the available resources, support services and intervention which is beneficial for the community. the major opportunities by the orientation visits are that social work trainees also can gain the insights of the cultural background, beliefs and values of the organization and community.

11.4 Threats: The threats which were faced during the visits by the social work trainees were the lack of time which can lead challenge while scheduling and conducting visits. At times, classes would be missed on the days of orientation visits. During some of the visits the organizations, social work trainees unfortunately getting emotionally attached to the community maybe later effect on the professional life for the social work trainees.

12. Conclusion: Overall, the orientation visits helped the social work trainees to gain knowledge about the various non-government organization working for the wellbeing of the community which include children, youth, women and people from marginalized communities. Additionally, the exposure to

different communities enhanced the understanding of orientation visits and challenges faced by different categories and communities throughout the society and in what all ways the challenges can be solved.
