1. The Center should follow the Regulations Governing Doctoral Degree Programme of the Bengaluru City University as modified from time to time and carryout Ph.D. Programme as per the said regulations.
2. A Research Advisory Committee (RAC) should be setup with the Chairperson of concerned P.G. Department of the University. This Committee should meet twice a year, preferably in May & November so that progress reports of the Research Students are scrutinized and forwarded through the committee.
3. The observations / conditions laid down by the Expert Committee of the Bengaluru City University in their report have to be fulfilled and compliance in this regard shall be sent to the University within 15 days of the receipt of this notification.
4. The Research Center should submit an undertaking in the enclosed pro-forma within 15 days of the receipt of this notification.
5. The Research Center will have to pay the prescribed annual affiliation fee and other fees (for Ph.D. Programme) to the BCU regularly and **apply for renewal of recognition six month before the completion of four years term.**
6. Guest / Temporary faculty of the department are not eligible to guide the students.
